Dear Member:

The Annual Membership Meeting will take place on Sunday, November 8, 2026, at 2PM at the Cooperative Meeting Hall at 55 Singer Court, Stratford, CT. Membership voting for 2027 Directors and the 2027 Budget will be done in the same manner as in the past, so that the Membership meeting will be guaranteed to take place as no quorum will be required. There will be more information to follow.

ATTENDANCE: Members are invited to the annual meeting, which will take place in the Cooperative Hall on Sunday November 8, 2026, at 2PM. Those members who cannot, or are unable to, attend are invited to submit written questions in advance of the meeting to the Cooperative Office. Written answers will be provided to all members who submit questions.

DIRECTOR ELECTIONS: Pre-nomination petitions for Director Candidates will be available on September 21, 2026, and must be returned to the Office on or before October 13, 2026. Candidates are reminded that, to be included in the Ballot, their petitions must comply with the By-Laws. Specifically, candidates should include a pre-nomination statement, which cannot exceed 50 words and should include an explanation of qualifications and experiences related to the position of Board of Director. Candidates for the election of Directors are free to make statements and answer questions at the Annual Membership Meeting on November 8, 2026, at 2PM. Ballots will be distributed to all members starting on or about October 22, 2026. Completed ballots may be submitted to the Cooperative Office starting on Monday, October 26, 2026, and must be returned to the Cooperative Office by 1:00PM on Tuesday, November 17, 2026.

BUDGET APPROVAL: Copies of the budget summary and ballots for the consideration of the 2027 budget will be distributed to the membership on or about October 22, 2026. Members having questions about the budget may get their questions answered at the Annual Membership Meeting on November 8, 2026, at 2PM. Completed budget ballots may be submitted to the Cooperative Office starting on Monday, October 26, 2026, and must be returned to the Cooperative Office by 1PM on Tuesday, November 17, 2026.

ELIGIBILITY TO VOTE: All Members are reminded that no Member/Owner shall be eligible to vote or to be elected to the Board of Directors who is shown on the books or management accounts of the Cooperative to be more than thirty (30) days delinquent in any and all payments due the Cooperative. The Directors of the Cooperative, shall be Members/Owners of the Cooperative, who occupy their dwelling Units and are recorded Members/Owners on the Membership/Ownership Certificates. In accordance with the By-laws, three positions on the Board of Directors are open for nomination and election this year.
